The change in the human soul condition and the view of the necessities of social life in the course of the ages. The migration of Atlanteans to Europe and Asia. In Asia, the spiritual developed in the soul without involvement of the bodily nature. In Europe, the spiritual developed through the instrument of the body. The coming of Christianity from Asia to Europe. Around the mid-fifteenth century, the gradual smoke-screening of the cosmic spirit and the nature spirit in European bodies, and the loss of the understanding of Christianity. Differences in the constitutions of Western and Eastern people today. War catastrophes occur because of the rejection of a new understanding of Christianity. Lloyd George and Woodrow Wilson. Direct understanding from person to person is achieved through spiritual forces. A new understanding of the Mystery of Golgotha. Transformation of casualness and sleepiness into mobility and industriousness of the inner soul life.

Memory, Intelligence, and the Senses in Relation

DORNACH, FEBRUARY 13, 1920

Ancient Mysteries and modern colleges. Ancient knowing and the connection of the human being with the cosmos. The metamorphosis of human soul life. Memory: strongly dependent on the bodily constitution; individual. Intelligence: less dependent on the bodily constitution; reflection through the body. Activity of the senses: least dependent; the process of seeing, as an example. Relationship of the "I" to memory, intelligence, and sense perception. The development of memory from the Moon condition; intelligence from the Sun condition; sense activity from the Saturn condition. Disposition of the various senses during the Saturn, Sun, Moon and Earth developments. Perception of the "I" by soul activities through the body. The life of angels in human memory; archangels in human intelligence; and archai in human sense activity. The relationship of the soul to spiritual substances (angels, archangels, archai) and the relationship of the body to food. The necessity to awaken consciousness. Practical effects in education. About opponents.

DORNACH, FEBRUARY 14, 1920

The connection of the three soul activities (memory, intelligence, sense activity) with the physical body; disposition in the consciousness form of earlier Earth conditions; connection to the hierarchies. The lower soul capabilities: feeling, desiring, wanting. Their significance for future Earth conditions. The playing into the upper capabilities by those below. Since the fifteenth century, the goal of freeing the upper soul abilities from those below. The future drying-up of the physical body and the lower soul capabilities; filling the higher soul capacities with revelations from the spiritual world. The social world as result of the lower soul abilities. The social order of Lenin and Trotsky determined by the drying higher soul. The danger of human civilization becoming paralyzed or rigid. The necessity of threefolding in public affairs: the separation of the state from the spiritual and the economical life.

DORNACH, FEBRUARY 15, 1920

The human physical organization points to the earthly, to the past and the future. The head organization as metamorphosis of the trunk and limb organization of the previous earthly life; the present trunk and limb organization as the foundation for the head organization of the future earthly life. Tendencies from the fourth post-Atlantean culture appearing in our fifth culture through the head organization of the reincarnating human being. The necessity for human beings to feel themselves placed in time as a twofold being. Anthroposophy instead of merely anthropology. Cooperation among the French nation, the English state, and the German folk for the welfare of Europe. The evolution of the French into a unified nation in contrast to the Germans. The legal-political nature of the French; the predestination of the Germans and the understanding for the spiritual to develop; the economic life of the English-Americans. Necessity to recognize threefolding in an historical connection. The defamation of Monsieur Ferrière

The Development of Imperialism: I

DORNACH, FEBRUARY 20, 1920

Untruthfulness in relation to historical manifestations in our time. Old Oriental imperialism. The ruler as a god; the Paladine as a higher being. The second form of imperialism: ruler and Paladine as god-sent. Church hierarchies as an image of the heavenly. Everything is viewed as symbol, as sign. The splitting of the second form of imperialism into two variations: Church communities and communities of the realm. Pope and emperor. Protestantism as protest against the real significance of the god-sent human being. What was preserved from the first form of imperialism in the Catholic Church, the manner in which Mohammedanism spread, and the despotism of Russian Czarism. The third form of imperialism: Anglo-American economic imperialism. Parliamentarianism, the will of the people, and the monarchy. The empty phrase, instead of signs and symbols. A colonial realm as a reality existing as an empty phrase. The task of the third phase of imperialism: to acknowledge the spiritual beside physical reality.

DORNACH, FEBRUARY 21, 1920

The foundation for a new spiritual life in Anglo-American imperialism. Economic life as the only reality in the emptiness. Beside the physical reality of economics a spiritual reality must be added. Existence of the prerequisite of this knowledge among the Western peoples. The inability in the Middle Ages to come to spiritual realities through symbols; lack of clarity about social organization. The German imperial rule since 1871 as illusion; the reality that developed out of it: the political conditions since November 1918. The secret societies of the English-speaking world. Empty phrases in exoteric, public life; symbolism that has become meaningless in esoteric societies. The outer power of the secret societies. The threefold impulse brings truth in the place of empty phrases or meaninglessness. Symbols in spiritual manifestations; Habsberger and Hohenzoller. Empty phrases and meaninglessness: Woodrow Wilson's book, *The State*.

The Development of Imperialism: III

DORNACH, FEBRUARY 22, 1920

The historical development of imperialism. First stage: will of the ruler as absolute power-factor. Second stage: consideration of persons, objects, deeds, etc., as symbols, as signs. The arising of personal judgment and the possibility for discussion and critique. Third stage: empty phrases and meaninglessness in relation to the soul life. Woodrow Wilson's codex of emptiness and empty words. Demand for a transformation of human thinking and feeling. Describing in pictures, not through definitions and judgments. The Roman Catholic Church as shadow-picture of the first stage of imperialism. Enmity between the Catholic Church and the secret societies. The state as shadow-picture of the second stage. Future call for a knowledge of the spiritual, brought about by feeling shame for recognized meaninglessness. The threefolding of the social organism. The social organism as a living being. Responsibility of the English-speaking world to bring real spirituality into outer economic imperialism. Actualization of an invisible kingdom of Christ through the will of the individual human being living in free spiritual life. Opposition to spiritual science.
